5. CHILDREN who are baptized who wish to join as child members prior to confirmation instruction.

# REQUEST FOR ASSOCIATE MEMBERSHIP

Associate Membership shall be made available to those who are seasonal residents or who, for other reasons must maintain full membership in another congregation.

### Privileges of Associate Membership

1. Being a servant of God in this community of faith.
2. Receive pastoral services and the Sacraments.
3. Use of the church buildings for baptisms, weddings, and funerals.
4. Opportunity to help with ministries of the congregation.
5. Teaching in Sunday School or other schools of the congregation.
6. Reception of congregational communications.
7. A record of all offerings on a bi-annual basis or request.
8. The right to vote at all congregational meetings.
9. May serve as committee chairpersons, but not hold elected office.
10. Represented as a group through liaison person on council.

Associate Members may change their status to regular membership upon request for transfer from their former congregation.

Associate Members who are legal residents of Florida should consider becoming full members at CVLC.
